Upon the acceptance and processing of this application by Story Time Felts, Inc. this application becomes a binding legal agreement and I will become an authorized Independent Story Time Felts Consultant. The applicant understands and agrees to the following:

1. I agree that I am an Independent Consultant and not an employee of Story Time Felts for any purpose including, but not limited to, federal, state, and local taxes. I am responsible for all of my own business expenses, income tax, and self-employment tax. Since I am not an employee I am not entitled to any Worker's Compensation insurance, unemployment compensation, or other type of employee benefits.
2. I agree to comply with Story Time Felts' policies and procedures as stated in any of Story Time Felts authorized publications, which is hereby incorporated into and made a part of this Agreement.
3. I will not misrepresent Story Time Felts in any manner and will not make any statements, claims or warranties that are not contained in Story Time Felts' written material. Applicant also agrees not to use, promote, make copies, or produce materials of any kind that are not previously authorized in writing by Story Time Felts.
4. I will apply my best efforts to the promotion and sale of Story Time Felts products and marketing opportunity. I will promote Story Time Felts' name in a manner favorable to me and to Story Time Felts.
5. I understand that there are no guarantees of profits or success in Story Time Felts Marketing Plan and I will present Story Time Felts Marketing Plan in accordance with the descriptions and guidelines set forth in any company-authorized publications.
6. I understand that I am free to sell Story Time Felts products and recruit Independent Consultants anywhere in the United States and its territories.
7. I understand that I am free to sell at home parties, craft shows, fairs, conventions, schools, churches, or any other organization. However, I may not sell to retail outlets, other fixed commercial outlets, or mail order catalogs.
8. I agree to submit all requests in writing for approval to advertise and/or use Story Time Felts name or Logo in any way including the Internet.
9. I agree that I need to purchase the orientation materials of Story Time Felts and that I am not required to maintain any inventory.
10. I understand that my sponsor (as listed on front) is my official recruiter of record. Story Time Felts will not agree to the transfer of an Independent Consultant to another sponsor and/ or Manager subsequent to the acceptance of this Application-Agreement by Story Time Felts.

11. I agree to be solely responsible for the maintenance of my account and will remit all payments at the time of ordering. Should applicant's account go to collections, applicant will be solely responsible for any collection fee up to 50% of the amount due and/or all legal fees incurred by Story Time Felts in the collection of applicant's account. Outstanding accounts will be charged interest at 1.5% per month.
12. I agree that this Application-Agreement shall be governed by the laws of the State of Utah. Should any provision herein be deemed unenforceable, the remainder of this agreement shall remain in effect. Furthermore, I agree that venue and jurisdiction for any legal action or claim shall be in the County and State of Story Time Felts' home office.
13. I understand that this Application-Agreement expires annually one year after my sign-up date. I may renew this Application-Agreement annually by notifying Story Time Felts and paying the applicable annual renewal fee as listed in company-authorized publications. By renewing my agreement, I agree to abide by the then current Application-Agreement.
14. I agree that a violation of any of the terms of the Agreement, including any of the policies and procedures of Story Time Felts may result in the termination of my rights as an Independent Story Time Felts Consultant. I may terminate membership by written resignation.
15. I agree not to assign, sell or otherwise convey to any other person or entity any of the rights, privileges or interests as a Story Time Felts Consultant without the prior written consent of Story Time Felts.
16. I agree to not engage directly or indirectly in the manufacturing, buying, selling or dealing in products that are of the nature sold and distributed by Story Time Felts, during the period of this agreement and for a period of three (3) years after the termination of this agreement.
17. I agree to call Story Time Felts within three (3) business days of receiving the Kit if I choose to cancel this agreement with no financial obligation. After three (3) business days I will pay a 10% restocking fee and all shipping. Kits are non-refundable after 30 days.
18. Most products require cutting, some may require assembly.
19. We reserve the right to make changes to the Kit and programs as listed.
20. This agreement may be modified from time to time to meet legal requirements or economic conditions.
